

**TERMS AND CONDITIONS FOR THE AWARD OF SCHOLARSHIP UNDER

Award of Scholarship:

The final selection of candidates would be merit based by the Project Steering Committee constituted for the project. The selected candidates would be required to sign and execute a bond with the HEC. The terms and conditions of the bond are available on the website and are also mentioned below.

Terms and Conditions Governing the Scholarship:

The terms & conditions of the award of scholarship are given below. Acceptance of scholarship under these terms and condition entail an acknowledgement of following obligations:

Obligations for an Awardee:

- i. An awardee will not change the course of study and the institution at which he/she is admitted and is specified in the letter of award.
- ii. An awardee will not avail any other scholarship during the period of his/her study.
- iii. An awardee’s father / guardian on behalf of his/her award is required to execute a bond with the HEC, ensuring that the awardee will not take part in any political and anti-state activity.
- iv. An awardee’s father / guardian on behalf of his/her award, shall sign an agreement with the authorized representative of Higher Education Commission (HEC), on judicial stamp paper, to the effect that in case the awardee fails to complete his/her study within well-defined time limits expected for the completion of studies being funded by HEC, he/she will refund to the HEC, the total amount spent on his/her studies by the HEC. **DEED OF AGREEMENT
FOR UNDERTAKING A COURSE OF STUDIES
HEC scholarship under project titled:
‘Provision of Higher Education Opportunities for Students of Balochistan & FATA
(Phase-II)’**

This agreement is made, on theday of2017, between

(1) Mr. / Ms.father / guardian

Ofhereby called the Scholar, and

(2) Higher Education Commission through the authorized officer in the HEC, herein after called the HEC.

WHEREAS Mr. / Ms.(name of scholar) has been selected by the Higher Education Commission for the award of undergraduate / graduate scholarship under the Scheme ‘Provision of Higher Education Opportunities for Students of Balochistan & FATA (Phase-II)’ and the scholar has agreed to accept the same on the terms and conditions governing this scholarship award.

Now this deed witnesses as under:

- i) This scholarship award shall initially be valid for one semester (4 months) and may be renewed up to a maximum total duration of 4-year (undergraduate program) / 2-years (postgraduate program), subject to satisfactory academic performance of the scholar.
- ii) The payment of allowances admissible under the scholarship program shall be made subject to the complete adherence to all rules and regulations governing the scholarship program as well as satisfactory performance in the authorized studies.
- iii) The scholar shall not change the specified course of studies nor register himself/herself for any other course or study program without prior approval of the HEC.
- iv) The scholar shall not extend the specified period of studies without prior approval of the HEC.
- v) During undergraduate /postgraduate program the scholar shall not undertake employment whether paid or otherwise.
- vi) The scholar shall refrain from engaging himself/herself in any political, commercial or any other anti-state activity incompatible with his/her program of studies.
- vii) In case the scholar fails to qualify the course for which he/she was awarded scholarship, the HEC reserves the right to recover entire expenditure from the Scholars/Guarantor.
- viii) The scholar shall not incur any debts during his/her studies and will clear all outstanding bills before leaving the university/ institute.
- ix) The scholar shall regularly submit the quarterly / six monthly progress reports on his/her assigned Program, through the Chairman of the department/ Director of the institute/ Registrar of the university to the Higher Education Commission and a final comprehensive report, immediately on completion of the study program.
- x) The scholar will be liable to disciplinary action as follows:
 - a) If he/she fails to avail of the award without any cogent reason acceptable to HEC/Government of Pakistan, he/she will be debarred from further study under any Scholarship Program run by HEC. If any financial loss is sustained as a result of his/her failing to avail the award, he/she will be held responsible thereof and liable to make good the same, apart from being liable to any penalty to be imposed by the Commission in this behalf.
 - b) If he/she violates any of the conditions specified under the Scholarships Program, he/she will be liable to pay the penalty as prescribed therein.
- xi) The scholar is liable to disqualification from HEC sponsored studies or such other disciplinary action as HEC may consider appropriate, if:
 - i) He / she violates any of the foregoing conditions, in his application form or final documents(discovered at a later stage) or
 - ii) He / she is found to have made any misstatement therein.
- xii) The awardees who are already enrolled on a nomination under any other program will provide their option of acceptance of the offer under the project titled ‘Provision of Higher Education Opportunities for Students of Balochistan and FATA (Phase-II).

AND THE SCHOLAR FURTHER COVENANTS, that in case of breach of any of the above terms and conditions as well as the rules / terms and conditions those governing scholarship award and / or his / her failure to comply all the conditions of the host university/ institute the scholar shall be bound to pay the HEC a penalty as prescribed by the HEC besides compensate the HEC by making a refund of the total amount of expenditure. The amount of penalty and the compensation as prescribed and assessed by the HEC shall be final and decisive.
